Executive Director's Report

Executive Director Tracy Alvord presented her report:

- **FY2025 Stats:** Tracy shares that before the new budget increase in FY2025, SORRB completed 516 cases. After the new budget for FY2025 there was a 71% increase with 882 cases completed.
- **FY2026 Stats (July 1, 2025- December 31, 2025):** Tracy states that although we are only halfway through the fiscal year, SORRB has completed 593 cases so far. She shares that the investigative team has

increased their case numbers from 1,011 cases in FY2024 to 1,642 cases in FY2025. Tracy also explains that SORRB continues to focus on identifying higher risk cases and that the influx of reevaluation requests and court ordered cases continues to grow.
