- **Training Topics:** Tracy states there will be no Training Topic by Markus today or in March. She asks the Board to please send in any ideas for topics so that Markus can create a monthly topic list for the

rest of the year. Markus will present at the Retreat in April and then resume monthly Training Topics after each Board Meeting.

She estimates that by next month's meeting, there will be at least 1 new Evaluator out of training and submitting cases. Board Chair, Frank Mullis, asks if all positions are at capacity now. Tracy explains that all Evaluator positions are at capacity, but there will be 3 new Investigators starting between 2/16-3/1 which will fulfill the Investigator positions as well.
