- **Investigator Report:** Chief Investigator Russ Finley presented the 2024 Annual Report regarding investigative numbers, procedures, and document retrieval.
- **FY2025 Budget:** Tracy presented the projected SORRB fiscal year 2025 report.

Case Review – Discussion and Vote

NOTE: cases are provided to the board members through the month prior to the board meeting, so the cases are read prior to the meeting. Each case is identified by number rather than name to increase objectivity. Any staff member or Board Member that has knowingly worked with the specific offender/court case has been recused and does not participate in the classification of that offender.

LEVEL 1 CASES - 5 cases presented for vote

- Discussion: Katie Gropper states concern with case 31232 regarding the offender's hostile behavior, lack of treatment completion and non-compliance with supervision. Clinical Evaluator, Amanda Aten, explains that this case was staffed with the other clinical evaluators and they all agreed that, since the offender had no sexual offenses in over 20 years, that the level 1 assessment is appropriate.
