Executive Director's Report

Executive Director Tracy Alvord presented her report:

- **FY2025 in Review:** Tracy reviews the growth of the agency from 7/1/2024 to present. Due to the hiring & training process there have been many hiccups but currently SORRB has grown from 5 admin positions to 9, 4 Clinical Evaluator positions to 21, and 3 Investigator positions to 12. These numbers include both full and part-time positions. Tracy, along with Markus and Amanda provide an in depth look into the Clinical Evaluator training process.
- **FY2026 Budget:** The funds for the SORRB budget in FY2026 will remain the same.
- **Next Board Meeting:** May 15, 2025

Deputy Director's Report

Deputy Director Richard Hammond presented his report:

- **CJCC:** Richard explains to the Board that SORRB was granted the CJCC grant funds again for a total of \$234,000 which has been allocated to 2 part time admin positions and 4 part time Investigators.
- **New Office Update:** Richard states there is a meeting set up for Tuesday 4/29 to again discuss office renovations. SORRB was to receive a new quote after revising the renovations to better fit the budget. More information to come.

Investigator Report

Deputy Director, Richard Hammond, recognizes Investigator David Sanders as Investigator of the Year. David completed 164 cases in an 8-month period. An honorable mention is given to Investigator Donnie Arrowood who completed 181 cases since starting with SORRB in August of 2024.

Clinical Evaluator Report

Clinical Evaluator Supervisor, Amanda Aten, recognizes Clinical Evaluator Justin Portivent as Evaluator of the Year. Justin completed 113 cases over an 8-month period. Honorable mentions were given to newer hires, Jeremy Stroop and Molly Wills.
