Approval of Minutes

The minutes from 07/11/2024 were voted on – all were in favor – Motion Carried.

Reports of Officers and Standing Committees

New Business

Executive Director, Tracy Alvord stated that the Board Members submitted their nominations for the Chair and Vice Chair positions. All were in favor for Frank Mullis as the Board's Chairman and Mindy Ackerman as Vice Chair.

Executive Director's Report

Executive Director Tracy Alvord presented her report:

- **PAC Presentation:** Tracy announced that she and Board Member Katie Gropper presented at the PAC Conference, and it went very well. They received positive feedback and hopefully they will be able to go back soon.
- **Judicial Review Hearing:** Tracy announced that SORRB was going to give feedback regarding the Judicial Review Hearing on August 5, 2024, but it was continued.
- **SORRB Office Move and New Hires:** Tracy announced that SORRB received last-minute notice about the Agriculture Building being vacated and everything is moving very quickly with Capitol Hill and all the changes. The Agriculture Building will remain standing, the two

buildings that are attached, 1 and 7 MLK, along with the old GBA building will be demolished. This will take from 3-5 years to complete, resulting in SORRB not returning. SORRB was notified that they only had until August 9th to vacate, rather than the original date of August 31st. DBHDD will provide one temporary cubicle desk for someone to be able to receive Orders for signature. Tracy added that we hired an administrative person who is aware that she will be working daily and in that office space. We have put in place a temporary change of address for our mail to be delivered. Our new address will be 200 Piedmont Ave SE. West Tower, Atlanta. GA 30334. The office space that we will be getting permanently will be on the balcony level in the Twin Towers, which will be available January or February of 2025. In the meantime, everyone else will be working remotely. Tracy stated that, when necessary, she and upper management will have travel meetings. However, she did ask DBHDD for the possibility of having time and a conference training room because Markus Wiegel is still training new hires. He began training 14 new hires on July 1st and 6 more on August 1st. There will be at least 4 more new hires on September 1st. If DBHDD is unable to accommodate, the training will be all virtual. Lastly, Tracy stated that she is very pleased with all the new hires and with the restructuring of SORRB.
