Executive Director's Report

Executive Director Tracy Alvord presented her report:

• <u>Appropriations:</u> During last month's Board Meeting, Tracy shared she was presenting for the first time to the House Appropriations subcommittee. Tracy states the testimony went great, with the assistance of Board Member Bert Reeves providing guidance. Board Chair Frank Mullis and Board Member Bert Reeves were able to attend in support, as well as SORRB's Clinical Evaluator Amanda Aten and SORRB's Chief Investigator Russ Finley. Tracy then was invited to present at the Senate Appropriations meeting, joined by SORRB's Research and Training Expert Markus Wiegel and SORRB Investigator Richard Hammond. Tracy feels this presentation was successful and is hoping for additional funding for SORRB to hire additional staff and complete more evaluations. Tracy will keep the Board updated with anything further.

- <u>2024 Board Retreat:</u> Tracy asks the Board to please check in with their SORRB email accounts regularly because there will be upcoming emails regarding Retreat details such as the agenda, location, meeting times, etc. The Board Meeting will be held in person at the Retreat, there will be no Zoom or YouTube stream. Board Member, Jim Morton asks for clarification on re-level cases versus re-evaluation cases. Tracy explains with re-levels, the offender has committed a sex offense, was classified by SORRB and subsequently reoffended so SORRB may re-level the offender. Re-levels cannot be completed without a new registerable sex offense conviction. With re-evaluations, the offender may not agree with the leveling therefore they request a new evaluation. Tracy clarifies that the Board Vote List sent to Board Members prior to the meeting has re-level cases placed separately and on the Board Meeting Case List the re-level cases are placed in the corresponding level category.
