Approval of Minutes

Vice Chair, Mindy Ackerman asks SORRB Legal Representative, Elizabeth Crowder if there are any updates regarding the influx of cases for the Board to review and what options there may be moving forward.

Elizabeth explains she has been exploring some possibilities and would like to set up a meeting with the Board Chair and Vice Chair to discuss before presenting all options to the Board. Mindy states a meeting will be scheduled.

Executive Director's Report

Executive Director Tracy Alvord presented her report:

- **Topic Request for Education Series:** Tracy states there will not be a training after today's meeting because of the short gap between Board Meetings but invites Board Members to continue emailing any training ideas they may think of regarding risk assessments. Research and Legislative Analyst, Markus Wiegel adds that previous trainings have included CSEM offenders, Risk Reducing Factors and Static Risk Factors. Markus will create a topic list that will be sent to Board Members before the next meeting.

Deputy Director's Report

Deputy Director Richard Hammond presented his report:

- **New Office Update:** Richard explains that a renovation quote has been approved for the new SORRB office space for \$202,465. Demolition will begin this week. There will be a meeting next week with the GBA contractors to discuss timelines.

Investigator Report

Chief Investigator, Russ Finley shares that the Investigators closed 181 cases last month compared to 119 in January. He states case completion numbers are growing and should continue to steadily increase as the new hires from February gain more experience.

Clinical Evaluator Report

Clinical Evaluator Supervisor, Amanda Aten states Board Members may notice 1-2 new Clinical Evaluator names in reports by June. All Clinical Evaluators have finished training with Markus and should be completing cases independently by July.
