REQUEST FOR SORRB CLASSIFICATION

SORRB has a significant backlog that started at its inception. For that reason, we prioritize resources for higher risk offenders. For us to expedite a case that has not been deemed a priority, you must provide the documents necessary to complete the entire evaluation. The following check list will assist you. **If any required information is missing, the case will not be expedited.** All received information will be verified, so please do not leave anything out.

All submitted documents must be PDF files.

Data storage devices (CDs, flash drives, etc.) will not be accepted.
